A Zoning Permit is required for construction of buildings, decks & farm structures. Zoning governs what is acceptable. Contact Rick Mansfield 231-225-8396.

ASK QUESTIONS: IT COULD SAVE TIME AND /OR

MONEY. Ordinance books are \$20.00

SPECIAL USE PERMITS:

Permit is \$450.00 if handled at a regular scheduled planning meeting or \$700.00 if a special planning meeting is held to cover additional costs.

TAXES INFO: Postmarks are not accepted. Must be received by due date.

Please call 854-1371 Sandy Gustman, Treasurer to get the amount due on late summer taxes prior to paying as interest of 1% per month is added beginning Sept.15th to the tax amount due thru February 28, 2023. Beginning February 17th and thru February 28th a 3% penalty is also added. Calling prior to making a late payment is a good idea to get the exact amount due. It will ensure full payment amount is made, saving a tax of a few dollars or less being returned delinquent to the county treasurer.

TIPS FOR TAX PAYING

- *Post marks are not accepted. Payment must reach the treasurer on or before February 14, 2023 or a 3% penalty will be added to the amount due on February 15, 2023. Summer taxes still due will have this added to those also. This amount is payable at the township level thru February 28, 2023. Any remaining amount due is returned delinquent and payable to the Oceana County Treasurer beginning March 1, 2023. It is best to wait a week to call there as records need to be updated. 231-873-3980. That office will help you with all the necessary information.
- *The township does not accept credit cards. Cash, checks and money orders are accepted.
- *Some errors that can delay the processing of your payment are: (1) not dating your check (2) amount of your check being incorrect note-checks are cashed on the cursive (written) amount, not the numerical amount (3) sign your check (4) make payable to: Greenwood Township. Any of these errors can add time to getting a corrected, cashable payment and timelines are really limited before more costs are added. Just take a second look to verify before sending your check.
- *Mortgage codes appear in the upper left-hand corner of the tax bill. If your bill shows an entity name requesting a copy of your tax bill a copy was sent there. Sometimes 2 entities request a copy of the same parcel. You may want to contact the entity if it is different than your mortgage holder. Also, if a second check is received after a receipt has been processed a refund is sent to the second entity. You may want to follow up to ensure your account was refunded that check.
- *Please note the required dates the treasurer is in the office on the front of this newsletter.

 Appointments can also be made. Please call 231-854-1371 to set a day and time that you want.
- *Marilyn Bowman is the township assessor and is who can help you with tax questions about assessment, owner information, veteran and poverty exemption, P.R.E. (Principle Resident Exemption) and other requirements that you need in order to insure the correct tax are being processed and assessed. 231-301-3303
- *December Board of Review convenes to answer questions also. Contact Jeff Hunt for date and time. 231-250-5769 This board has limited changes it can address and you may be instructed to seek attention at the March 2023 Board of Review. The date and times of the board meeting will be printed on the Change of Assessment Notice that is mailed in February.
- *Please call when you have a question about your tax bill. There are not any questions that can not be answered. The sooner things are questioned the easier it is to correct any errors and if there is something to adjust it is easier to do prior to payment.
